

## ALEP Directors' Report Tuesday 6 December 2022

After the challenges of the pandemic and a brief flurry of government activity, including the introduction of the Leasehold Reform (Ground Rent) Act 2022, we reach the end of what has been a relatively quiet time for the sector in terms of updates. There have been few new cases of note and tribunals remain online. We have welcomed and bid farewell to a number of ministers including Lord Greenhalgh, and have recently seen the return of Michael Gove to the department; it remains to be seen what lies ahead in this regard – can we expect a New Year announcement as we have witnessed in previous years?

That said, it is clear that 2022 has brought many challenges to our members; not only do we have the question of how and what to advise our clients in the face of the unknown, but we are all looking at increasingly turbulent economic times ahead.

Whatever is happening in the wider industry and the world at large, ALEP has continued to lead the way in this niche sector, facilitating networking and spreading best practice amongst its members. Our lecture and conferences have made a welcome return to an in-person format, and we have held three online sessions over the course of the year.

Our thanks also go to Liza Smith, who stepped down from ALEP earlier this year, as well as Lisa Carter who has taken up the reins.

Finally, ALEP's successes and achievements in this – and all its 15 years - would not have been possible without the continued support and loyalty of our members. By attending our events in person and online, participating in consultations and planning, and supporting the Association in so many ways, you continue to help us to take ALEP from strength to strength.

As we draw to a close, we would like to wish everyone all the very best and hope that 2023 brings success, happiness and continued good health.

## Anna Bailey – response to ALEP at 15

My late brother, Alex Greenslade, and I agreed back in 2005 that the leasehold enfranchisement sector could really do with a dedicated networking and training group. In 2007, with the support of both Peter Haler (then Chief Executive of the Leasehold Advisory Service) and an initial founding committee, we launched the Association formally at the Lease Conference in May 2007 and celebrated that evening on the Embankment's TS Queen Mary.
