### Cancellations and Substitutions

If you wish to cancel a booking for the ALEP Golf Day being held on Thursday 16 May, refunds on cancellations will be made as follows:

- Received in writing by email on or before 2 May – 50% refund;
- Received after 2 May – no refund.

You may send an alternative player if you are unable to attend without incurring additional fees. You must inform ALEP of the alternative player's name by 10 May 2024.

### Dietary or Access Requirements

Specific dietary and/or access requirements must be notified at the time of booking. Please note that the additional cost of any kosher meals will be invoiced to players.

### GDPR

ALEP may use this information to advise you from time to time of forthcoming events.

ALEP will pass your name and any other personal data to the venue as may be required to comply with reservation, safety and security policies and procedures.

ALEP will publish an attendance list (consisting of players' names and organisational details) which will be distributed to all players and sponsors attending the Golf Day.
